

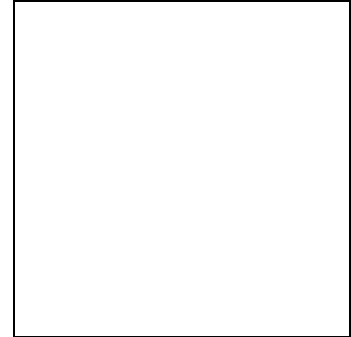

## FORM OF APPLICATION FOR ISSUE OF INTERNATIONAL DRIVING PERMIT TO DRIVE A MOTOR VEHICLE IN OTHER COUNTRIES

I apply for an International Driving permit to enable me to drive vehicles of the following categories –

### CATEGORIES OF VEHICLES FOR WHICH THE PERMIT IS APPLIED FOR

- (A) Motor Cycle Category L1, and Category L2.
- (B) Motor Vehicles, other than those in Category (A) above, having a permissible maximum mass/weight not exceeding 3,500 Kgs (7700 lb) and not more than eight seats in addition to the driver's seat in Category M1.
- (C) Motor Vehicles used for the carriage of goods and whose permissible maximum mass/weight exceeds 3,500 Kgs (7700 lb).
- (D) Motor Vehicles used for the carriage of passengers and having more than eight seats in addition to the driver's seat.
- (E) Combination of vehicles of which the driving vehicles is in a category or categories for which the driver is licensed (B and or C and or D) but which are not themselves in that category or categories.
